Vendor Fees

The following fees are due with your application. Vendor fees can be paid with either check or credit card (Visa or Master Card)

Food Vendor Fee is \$160 for a 10 x 10 space

Logistics

- Most food vendors are located on 4th Street between Grover & Front Street. Some "dessert" vendors will be located near 6th Street. You must stay inside the footprint of your assigned space. No displays may protrude out into the walkways.
- We will provide the spaces; you provide your own canopy, table, chairs, extension cords, etc.... As it can get windy, **We require that you weight your canopy.**
- We reserve the right to refuse entry to any vendor. We attempt to limit the number of vendors selling the same type of items, but do NOT guarantee product exclusivity.
- Any special booth requirements will need to be confirmed at time of application and noted on the application.
- It is expected that all vendors will adhere to all local, state and federal guidelines regarding permits, signage, types of items sold, collection of sales tax, etc. City of Lynden sales tax location code is #3705.

- **Food vendors must carry Pepsi products & Aquafina water, per our sponsorship agreement with Pepsi**
- Vendors agree to follow the direction of Festival staff regarding load-in/out rules during the Festival, for the safety of all attending.
- All vendors must adhere to on-site decisions of the festival Staff.

Entry Deadlines & Hours of Operation

Deadline for vendor entry is **Friday June 9th**. If you are not chosen for the market for any reason, we will return your vendor fee. Any special needs must be discussed in advance. Vendors selected for the market will be contacted by e-mail with additional setup information shortly following the June 9th application deadline.

Saturday July 15th
