Parade Judging (All Entries):

1. Takes place as units pass the reviewing stand in downtown Lynden.
2. Bands and marching units are to continue in a forward motion at all times.
3. Awards will be delivered the week following the parade. Final results will be listed on www.lynden.org.

Requirements and Safety Instructions:

1. Drivers must remain with their vehicles. Rider(s) must remain on the entry for the duration of the parade route (no riders may unload until the entry has come to a full and complete stop; entries returning at the end of the parade along Grover St. may not unload until 10th & Grover).
2. One (1) adult should accompany every five (5) children to maintain proper safety & supervision.
3. No smoking on or near floats; A serviceable fire extinguisher must be on hand for each float.
4. All vehicles must be in good mechanical condition.
5. Each animal entry **MUST** provide its own clean-up unit.
6. Liability insurance is the responsibility of the entrant(s) and is *required* for entry in the parade.
7. City by-laws prohibit throwing merchandise, candy, etc. from any float. Adults may walk along the curb to hand out candy **ONLY** as long as they keep pace with the parade.
8. **NO LITERATURE/FLYERS OR OTHER HANDOUTS OF ANY TYPE ARE ALLOWED.**
